Terms of Use

Collection and Use of Information

We use ‘cookies’ on starreadytomovehomes.com. A cookie is a token that a server gives to your browser when you access a website. For instance, our server may set a cookie that keeps you from having to enter a password more than once during a visit to one of our websites. In all cases in which cookies are used, we will not collect personally identifiable information except with your explicit permission.
